#### CONSTITUTION OF THE PACE UNIVERSITY NEW YORK FACULTY COUNCIL

#### PREAMBLE

The Pace University (University) New York Faculty Council (NYFC) is organized to establish a structure within which the members o the NYFC may engage in a coo!erative e ort directed toward the !rogressive im!rovement o the University'

#n order to ensure meaning ul aculty !artici!ation in the decision making !rocess at the University and to establish e icient communication between the aculty and other com!onents o the University the NYFC su!!orts the aculty governance structure called the %oint Faculty Council (%FC) and !romulgates this constitution"

#### Article I. Statement ! P"r# \$e

The aculty is the body with !rimary control and res!onsibility or curriculum\ sub\est matter and method o instruction\ academic research\ aculty status\ and those as!ects o student li e that are related to the educational !rocess" This right is to be generally re erred to as the aculty's determinative !ower"

The NYFC\$ through the %FC\$ is the aculty re!resentative body delegated to share in decision making in areas o general !olicy and management o the University Faculty \*\hat{k}\* selected or selected by the

The NYFC is the legislative body through which the New York aculty makes decisions in areas o its determinative !owers" The NYFC is also the mechanism or the NY aculty to make recommendations to the ) oard\sqrt{sthe President o} the university or other a!!ro!riate !ersons or bodies within and without the University" (n matters o University+wide concern\sqrt{sthe NYFC} may vest its authority in its re!resentatives to the \%FC when the NYFC\sqrt{by a ma\cdot\sqrt{ority} vote\sqrt{deems it a!!ro!riate to do so"}

(b) # a secret ballot is re8uested or any vote or motion at a meeting\$ and i that re8uest is seconded\$ then the NYFC 3\*ecutive shall conduct that vote or motion with a secret ballot using !a!er votes without calling or a vote on whether to conduct a secret ballot"

0c1 3 lections or the C:FPT re!resentatives and the members of the C:FPT .!!eals committee shall be conducted as ollows. The 6 ecretary of the NYFC will circulate a ballot via email to the membershi! of the NYFC and allow members to vote via emails setting a deadline or submitting the ballot of no later than AB hours be ore the NYFC meeting where an in+!erson ballot will also be held. The 6 ecretary will !re!are a voting roster or use at the meetings showing which members have already cast email ballots 1 those who cast email ballots be ore the deadline will be not allowed to vote at the meeting.

## Article VII. C mmittee\$

The Council shall have the ollowing standing committees with unctions duties and membershi! as hereina ter set orth. They shall also have such duties as may be con erred rom time to time by the NYFC or by the 3\*ecutive Committee. The NYFC may create other standing committees as resuired however the committees listed herein shall be considered as !ermanent standing committees.

The !rimary res!onsibility o all NYFC committees and NYFC re!resentatives to University committees is to re!ort their indings to the NYFC in whatever orm the committee inds most a!!ro!riate"

,oting members o the NYFC are eligible to serve on all committees" 3\*ce!tions\$ who must be tenured\$ are the Chair and the First ,ice+Chair o the Faculty Council and the aculty members on C: FPT and the .!!eals Committee"

The term o o ice on any committee is two (=) years unless otherwise s!eci ied" Nominations to a committee may be made at any time by contacting the 6ecretary" #t is suggested that i an elected committee member is unable to serve on a committee or which alternates are not !rovided through election\$ then the committee member may send an alternate in his<a href="his-her!lace">his-her!lace</a>"

/ hen a committee is irst constituted i it contains seats which must have staggered terms then when the irst election is held or this committee terms o varying lengths will be assigned to each candidate based on the number o votes t 1/15 / on

should have staggered terms should or any circumstance lose the staggering o terms then the ne\*t election or this committee will re!eat the election !rocedures described or the irst election to establish the staggered terms

# Secti n ). 3lection o Committee 5 embers

The slate o willing candidates shall be a combination o a list o candidates !ro!osed by the Nominations Committees sel +nominations and nominations o other members !resent at the meetings o the s!ring semester o odd+numbered years and those members who send in nominations in res!onse to an emailed call or nominations which will be circulated during February. The 6ecretary will !re!are a ballot or all committee !ositions that combine nominations rom all o the sources discussed above. Neither the 6ecretary's re!ort nor balloting on these nominations will identily the originating source or any nomination.

The inal slate o committee members will be a!!roved or their term o o ice by the NYFC either in .!rils or when the ballot incor!orating nominations rom all sources (described above) has been !re!ared but no later than the 5 ay meeting" . se!arate ballot or alternate seats or untenured aculty will be held no later than the irst meeting o the Fall semester ollowing the regular committee elections in the !receding 6!ring

Committee chairs will be elected by a mallority vote on the committee members at the beginning on the new academic year. This meeting will be called by the ormer chairs or in the absence on a former chairs by a convener designated by the NYFC Chair.

#n the event o vacant seats or resignations by committee members the NYFC 3\*ecutive or the Nominations committee may a!!oint a re!lacement member to serve the balance of the term drawing first from the elected alternate members of the committee in 8uestion1 such a!!ointments will be brought to the ne\*t meeting or ratio ication."
