

SUMMARY ANNUAL REPORT

For Pace University Defined Contribution Retirement Plan

This is a summary of the annual report for Pace University Defined Contribution Retirement Plan, EIN 13-5562314, Plan No. 001, for period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$50,670,944. These expenses included \$341,863 in administrative expenses, and \$50,329,081 in benefits paid to participants and beneficiaries. A total of 3,572 persons were participants in or beneficiaries of the plan at the end of the plan year,

Paperwork Reduction Act Statement

According to the Paperwork Reduction Act of 1995 (Pub.
