Art. 32 - Bench Composition

a. The Board shall consist of seven members, including the Chair, who shall be appointed by the Board of Directors for a term of three years. The Board shall elect a Chair and a Vice-Chair from among its members. The Board shall also elect a Secretary and a Treasurer from among its members. The Board shall meet at least once a year and may meet more frequently as it deems appropriate. The Board shall have the authority to call special meetings and to determine the agenda for such meetings. The Board shall have the authority to establish rules of procedure for its meetings. The Board shall have the authority to delegate its powers and duties to committees and subcommittees. The Board shall have the authority to hire and fire its own staff. The Board shall have the authority to enter into contracts and to incur obligations on behalf of the organization. The Board shall have the authority to sue and be sued. The Board shall have the authority to do all such other acts and things as may be necessary or proper to carry out its duties and to achieve its purposes.
